

WASHINGTON TOWNSHIP TRUSTEES REGULAR MEETING  
HELD Thursday, August 19, 2021 AT 7:30PM

Meeting was called to order by Vice Chair, Mr. Jack Butler. Members present were Mr. Jack Butler and Mr. David Yoder. Member absent was Mr. Bob Entenmann. Also present was Fiscal Officer, Sara Hammett and Tim Boggs. Mr. David Yoder made a motion to waive the reading of the minutes, to pay the bills presented and to approve purchase orders. Mr. Jack Butler seconded the motion and the motion carried with a roll call vote of all ayes. A payment listing of bills presented are attached hereto and made apart hereof. A Credit Card Transaction Summary for July 2021 was presented for approval.

Resident's Don and Joyce Krupka at 2240 Haywood Drive were present and discussed having issues with their neighbors in regards to zoning issues, etc. Tim Boggs, Zoning Inspector had sent letters to the neighbors about a year ago and they never responded. Mr. and Mrs. Krupka presented photos of canvas sheds at 2236 Haywood Drive and wondered about being a zoning violation and 2250 Haywood Drive for issues with cats and a metal kennel cat hotel and wondered about being a zoning violation. Zoning Inspector Tim Boggs will take additional photos and follow-up with Legal Counsel and advised to Mr. and Mrs. Krupka to contact the Animal Shelter about the cats.
