WASHINGTON TOWNSHIP TRUSTEES REGULAR MEETING HELD Thursday, June 2, 2022 7:31 pm

Meeting was called to order by Chair, Mr. Dave Yoder. All members were present with the exception of Trustee, Mr. Jack Butler. Also present were Fiscal Officer, Annette Depue, Road Superintendent, Andy Romoser, Fire Chief Dave Compton, and Zoning Inspector, Tim Boggs. Fiscal Officer, Annette Depue read the minutes from the Special Meeting held on May 19, 2022. Mr. Bob Entenmann made a motion to waive the reading of the regular meeting minutes, to pay the bills, approve Purchase Orders, & approve reallocations as presented, Mr. Dave Yoder seconded the motion and the motion carried with a roll call vote of all ayes.

Chief Compton reported the complaint in regards to burning outside the allowable hours on Taylor Road was handled with a brochure/letter, stating the burning laws, being sent to violator. Mr. Bob Entenmann also followed protocol and mailed a burning laws brochure to Washington Township resident in violation, who returned the letter. Annual ladder testing is complete and all ladders passed inspection. Engine 133 is having issues with the pump and it is being worked on.

Mr. Dave Yoder reported on the demolition of Vanderbilt Road property and that it is scheduled for completion by June 15.

Tim Boggs, the Zoning Inspector received a complaint about outside animals at 560 E. Hanley Road, so far there is not a violation, but will be monitored. A complaint was made in regards to a car parked at the end of Straub and it has been asked to be moved. A complaint was received on 735 Joselynn Avenue for multiple parked cars, it will be monitored. Resolution #18-22 for Tyler Pauley's property 2167 Cloverdale Dr. for removal of Garbage & Debri Nuisance was presented. Mr. Bob Entenmann made a motion to approve and Mr. Dave Yoder seconded the motion and the motion carried with a roll call vote of all ayes. Mr. Boggs received requests for permits for the new fire station.

Mr. Andy Romoser, Road Superintendent asked to award Lake Erie Construction the \$90,725.00 bid for various guardrail replacements on township roads. Mr. Dave Yoder made a motion to accept, Mr. Bob Entenmann seconded the motion and the motion carried with a roll call vote of all ayes. Additional signs were added to Hull Road due to detour on Mans-Lucas Road. All cemetaries, curbs, etc. that the township is responsible for have been mowed at least once. Holes were patched on Cloverdale. The Shelby Company responded and will be meeting with Andy & Mr. Jack Butler on Tuesday, June 7th.

Fiscal officer updated trustees with Cash Summary by Fund report.

There being no further business, Mr. Dave Yoder made a motion to adjourn the meeting, Mr. Bob Entenmann seconded the motion, the motion carried all ayes, and the meeting ended at 9:10 pm.
