## WASHINGTON TOWNSHIP TRUSTEES REGULAR MEETING HELD Thursday, August 4, 2022 7:30 pm

Meeting was called to order by Chair, Mr. Jack Butler. All members were present, except Mr. David Yoder. Also present were Fiscal Officer, Annette Depue Road Superintendent, Andy Romoser, and Zoning Inspector, Mr. Tim Boggs. Mr. Bob Entenmann made a motion to waive the reading of the regular meeting minutes, to pay the bills, approve Purchase Orders, & approve reallocations as presented, Mr. Jack Butler seconded the motion & the motion carried with a roll call vote of all ayes.

Mr. Andy Romoser reported that he spoke with Marc Haring of 1092 Kings Corners Road in regards to the damaged culvert that is causing occasional flooding. The option of a bridge was discussed, as well as suggesting the possibility of discussing it further with Richland County Engineer, Adam Gove. Mr. Bob Entenmann plans on speaking with him. Mr. Romoser is requesting a stop sign from ODOT to be placed on the left side of the road of Mid-Bellville & State Route 97.

Mr. Tim Boggs reported that certified mail was returned by David & Francis Smith at 1202 Keefer Road. This is the second time the letter has been returned. Certified mail was also returned by Joyce & Samuel Miles of 2124 Greenbriar Drive. Since the last meeting, there have been 3 permits approved. One to Kelly Kordy of 3298 Middle-Bellville Road for a barn, Bill Thompson of 1409 Kings Corners Road for a barn, and Hammets at 817 Taylor Road for new construction. There has been a request submitted to change the zoning from Agriculture to Business on State Route 42. He reported that 735 Joselyn remains to be monitored & presented photos that there have not been any changes. Bellevista is still being monitored. He submitted additional photos of 2764 Lakeside Drive, it will be going to court. Mr. Tim Boggs also presented the documents to accept the drawings for the new building permit. Mr. Bob Entenmann moved to accept, Mr. Jack Butler seconded the motion & the motion carried with a roll call vote of all ayes.

Mr. Bob Entenmann distributed a copy of a document explaining Ballot Confusion regarding HB140 that impacts Property Tax levies. He also presented additional information in regards to the Opiod settlement in which everyone agreed that Washington Township should apply.

Mr. Jack Butler reported that Tuesday, August 2, there was a planning meeting /workshop on the new building to get approval on the holding tank so that the project is not held up by the EPA. The placement of wells was approved. Ohio Edison will be also placing poles where necessary at the site.

Fiscal officer updated trustees with Cash Summary by Fund report.

There being no further business, Mr. Jack Butler made a motion to adjourn the meeting, Mr. Bob Entenmann seconded the motion, the motion carried all ayes, and the meeting ended at 8:42 pm.
