Mr. Jack Butler moved to give an increase in hourly wages to the road department employees which will take effect on January 8, 2023, Mr. Dave Yoder seconded the motion, the motion carried all ayes. Mr. Romoser presented to the trustees a quote for a new salt shed and storage shed at the new building site. He also contacted Dan Herrold at MS4 to verify all of the EPA requirements.

Fiscal officer presented the 2023 Temporary Appropriation Budget. Mr. Bob Entenmann made a motion to pass the budget, Mr. Jack Butler seconded the motion, the motion carried all ayes. Mr. Jack Butler, Chairperson, signed the contract with Rumpke to continue trash service and also signed the agreement with Keith Kisling for lease of the land. Fiscal Officer updated trustees with Cash Summary by Fund report.

Mr. Jack Butler presented and reviewed the budget for the new Fire Station, verifying costs. Mr. Dave Yoder made a motion to accept the bid, including the add-ons for Phase 2. Mr. Bob Entenmann seconded the motion, and the motion carried all ayes. The required paperwork for USDA was signed to be sent to Mull & Weithman architects.

There being no further business, Mr. Jack Butler made a motion to adjourn the meeting, Mr. Bob Entenmann seconded the motion, the motion carried all ayes, and the meeting ended at 10:29 pm.
